1. The height of concrete boundary wall is not 6 feet in all sides -

8. There is variation in land area in the land certificate as well as in OASIS data. The land area mention in OASIS is 4000 sq mt. and playground is 36000 sq mt. whereas as per land certificate it is 13980 sq mt. and in application it is mention as 13961 sq mt. may be clarified.
